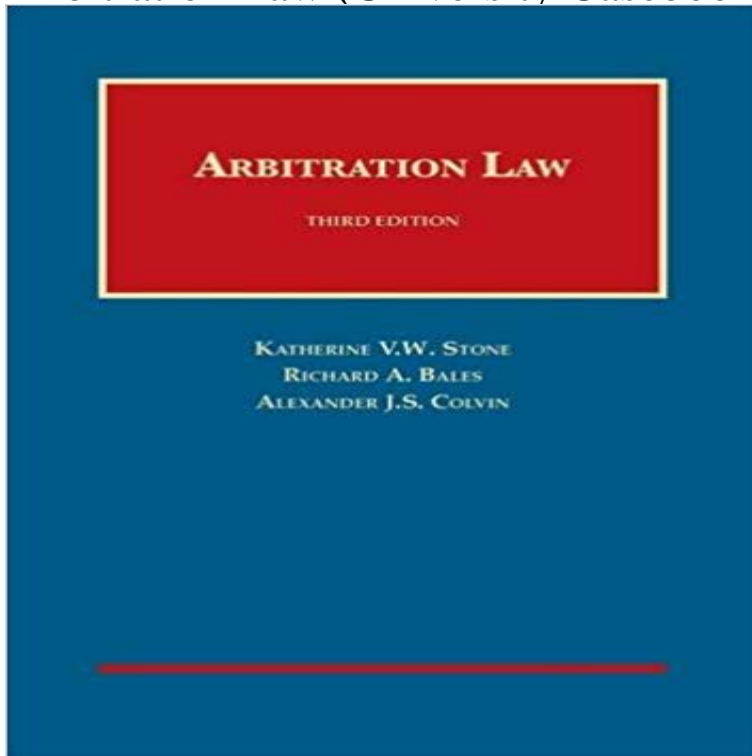


## Arbitration Law (University Casebook Series)
