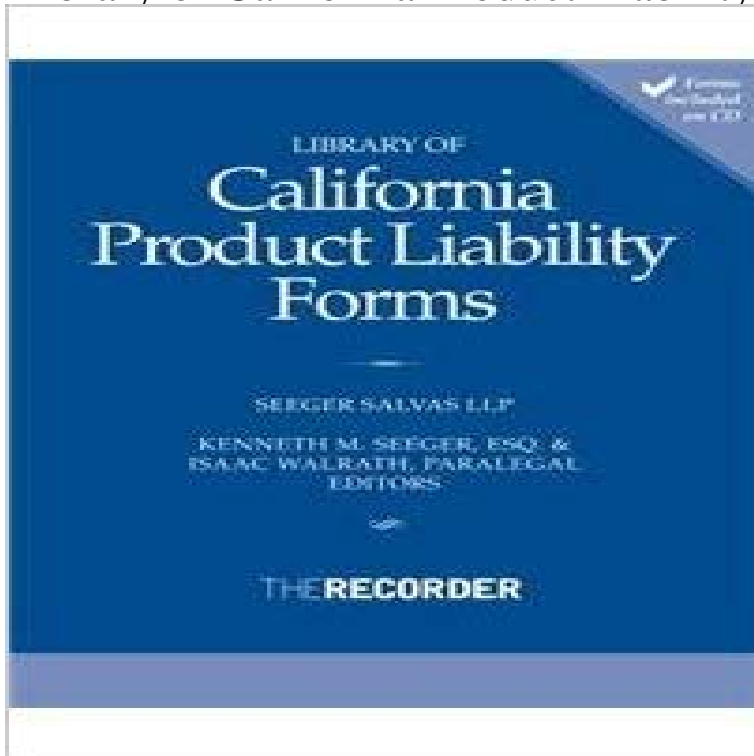


Library of California Product Liability Forms
