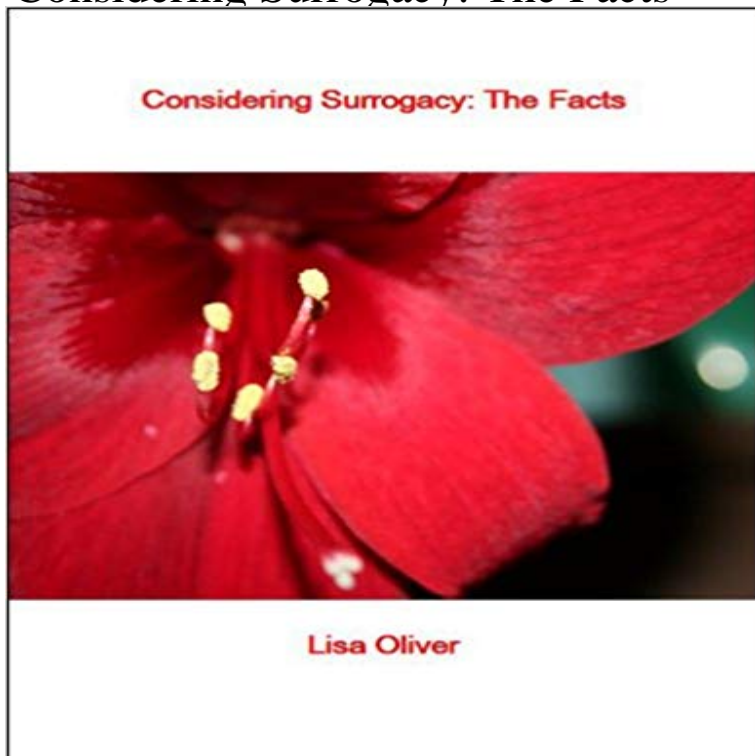


Considering Surrogacy: The Facts
