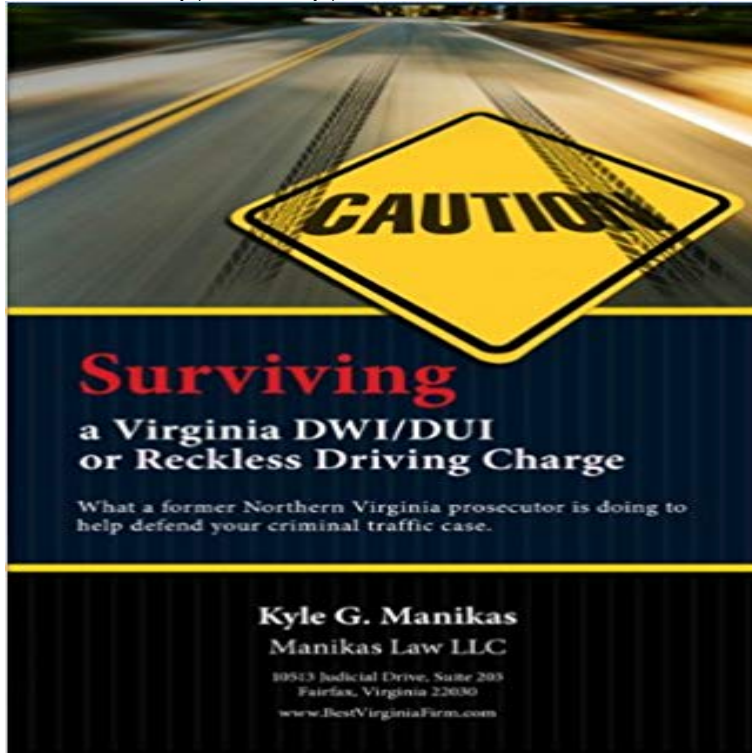


Surviving a Virginia DUI/DWI or Reckless Driving Charge
