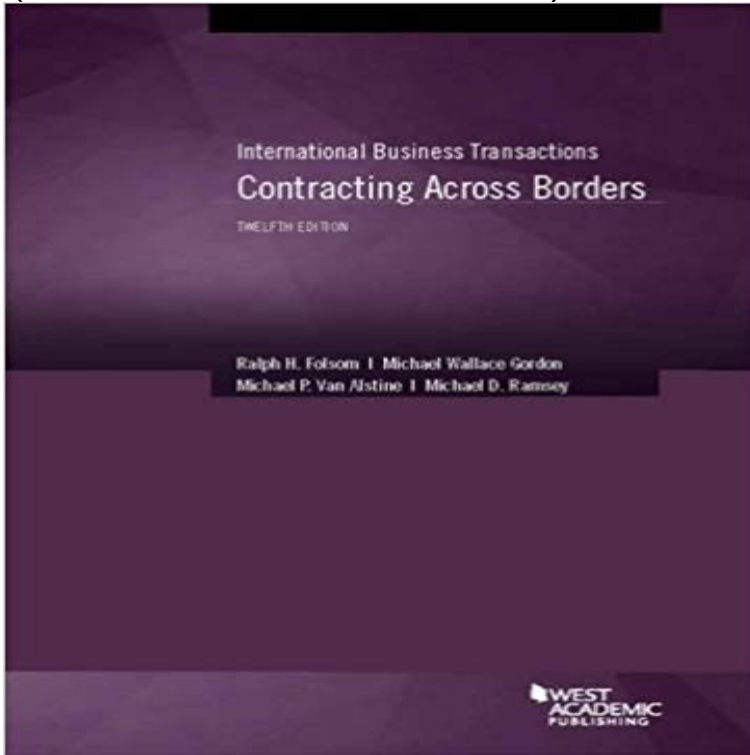


# International Business Transactions: Contracting Across Borders (American Casebook Series)
