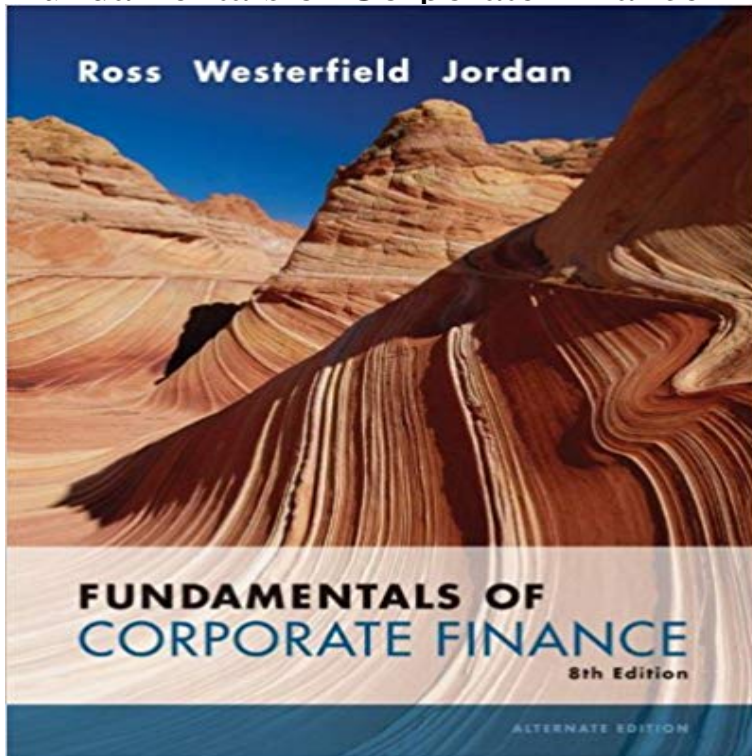


Fundamentals of Corporate Finance Alternate Value 8th Edition
