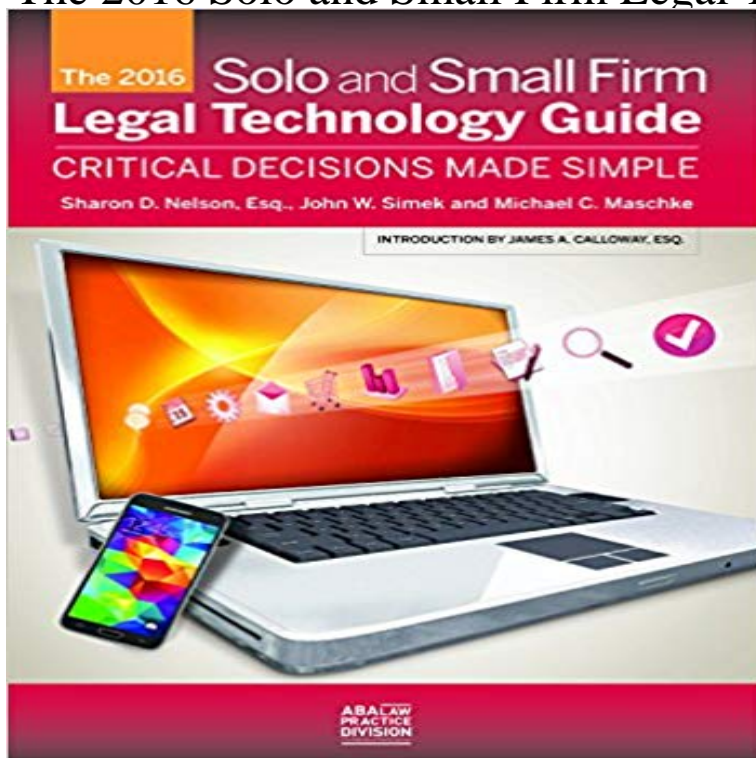


## The 2016 Solo and Small Firm Legal Technology Guide
