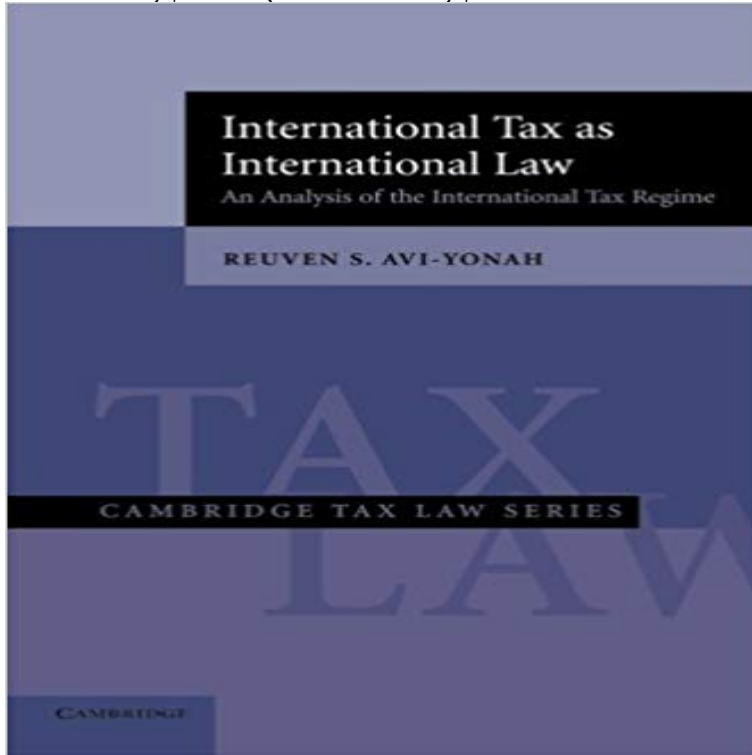


International Tax as International Law: An Analysis of the International Tax Regime (Cambridge Tax Law Series)
