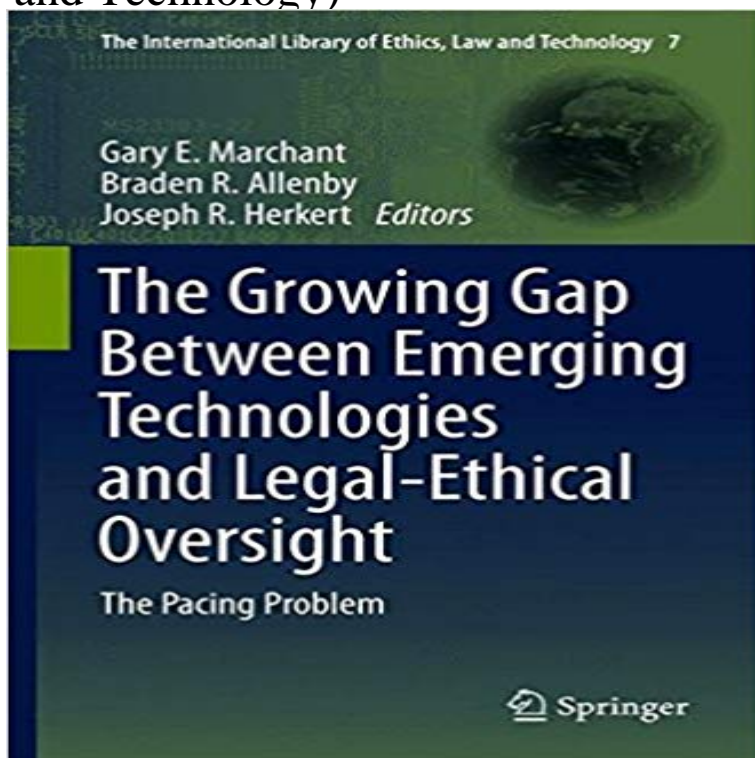


The Growing Gap Between Emerging Technologies and Legal-Ethical Oversight: The Pacing Problem (The International Library of Ethics, Law and Technology)
