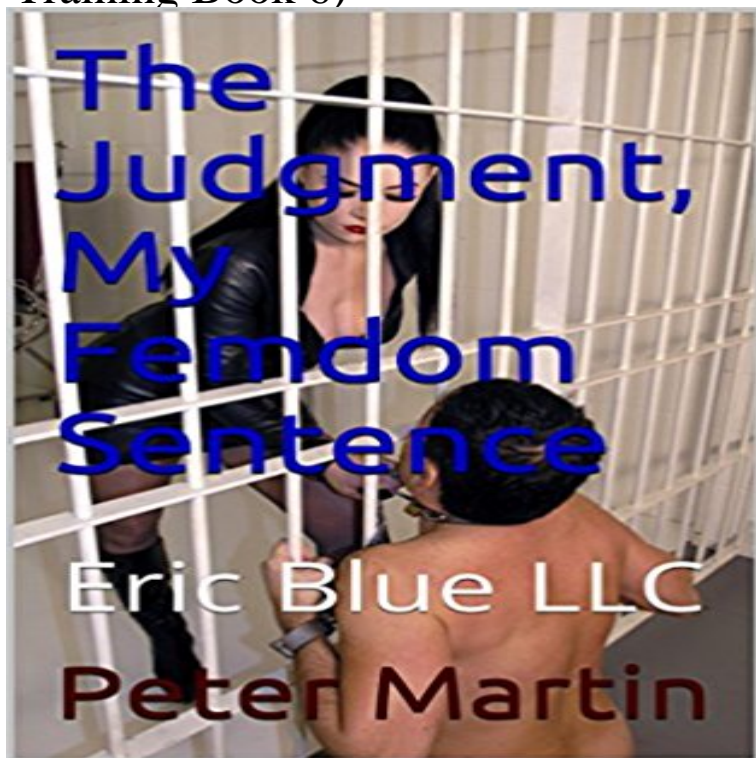


## The Judgment, My Femdom Sentence: Eric Blue LLC (Scars of the Whip Training Book 6)
