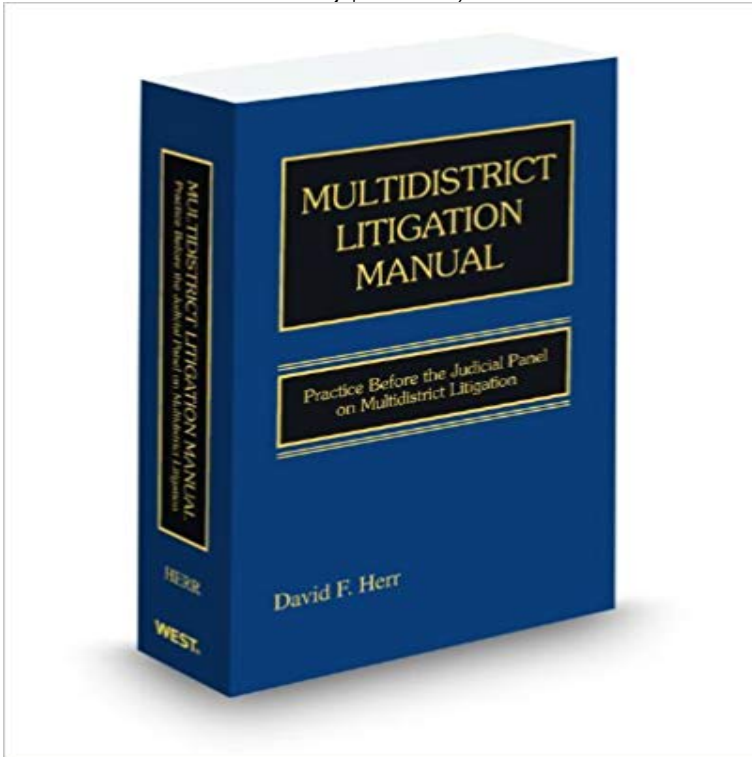


## Multidistrict Litigation Manual: Practice Before the Judicial Panel on Multidistrict Litigation, 2011 ed.
