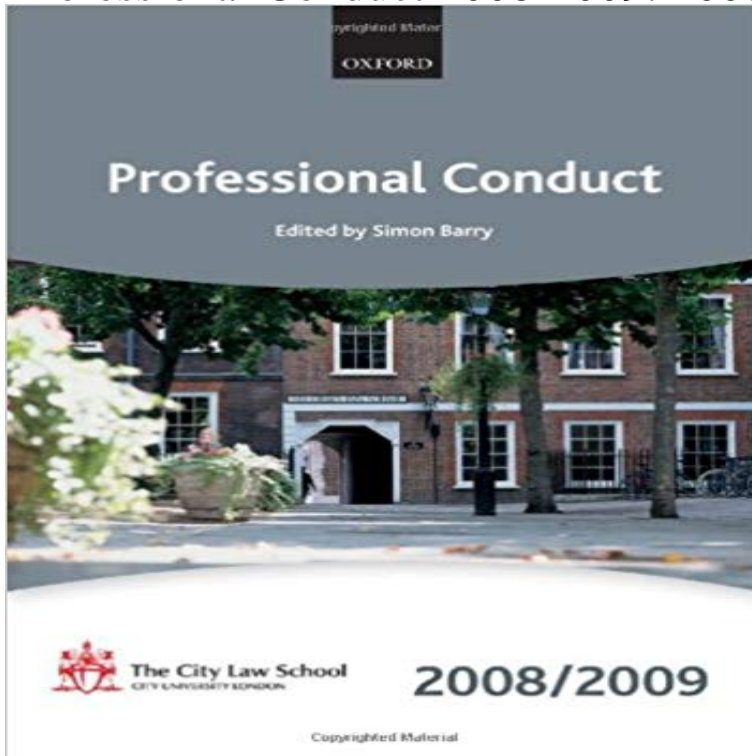


## Professional Conduct 2008-2009: 2008 Edition (Blackstone Bar Manual)

Potentially problematic conduct areas are identified throughout, and practical guidance is given on the correct approach to follow in such situations should they be encountered in practice. The manual also features a number of exercises designed to encourage the reader to consider how to apply professional conduct principles to realistic scenarios. For ease of reference, the full Code of Conduct is provided as an appendix at the end of the manual. Professional Conduct is essential reading for all trainee barristers, and is a useful reference source of reference for practitioners seeking to refresh their knowledge of the rules and principles of professional conduct which govern the profession.
