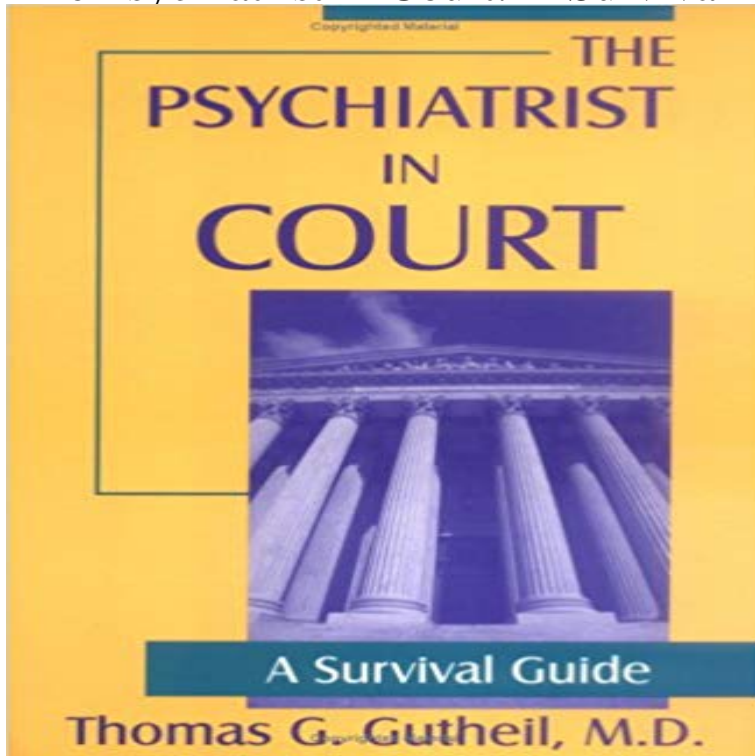


The Psychiatrist in Court: A Survival Guide
