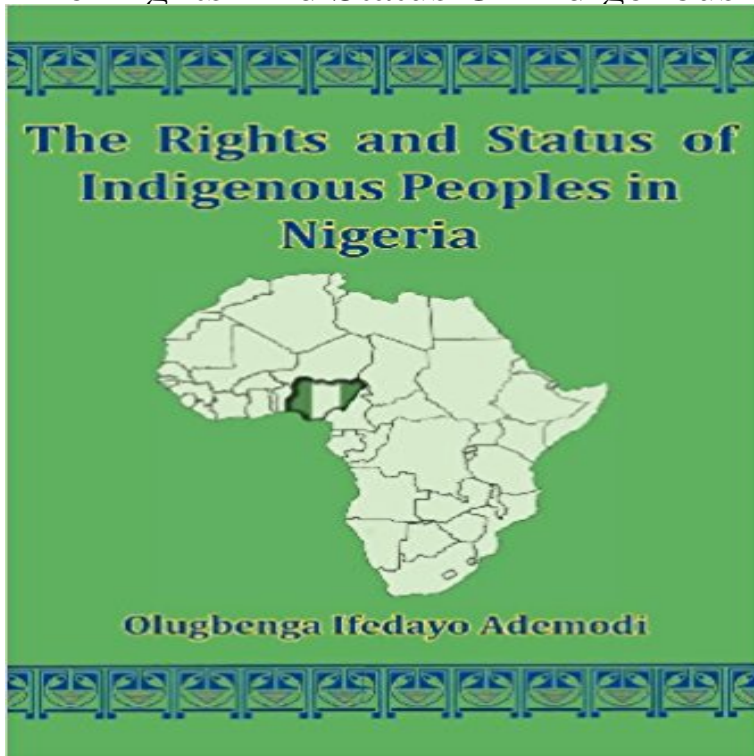


## The Rights And Status Of Indigenous Peoples In Nigeria
