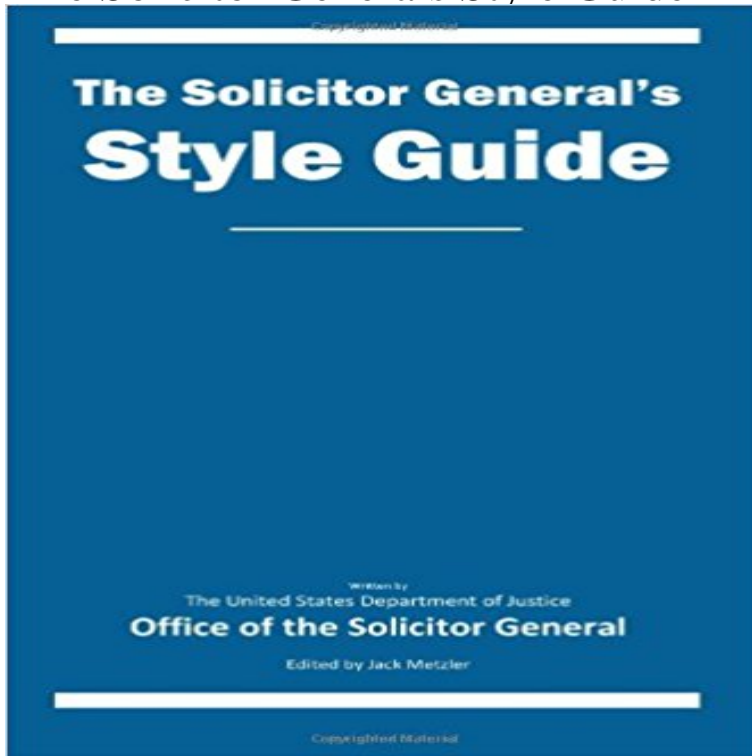


The Solicitor Generals Style Guide
