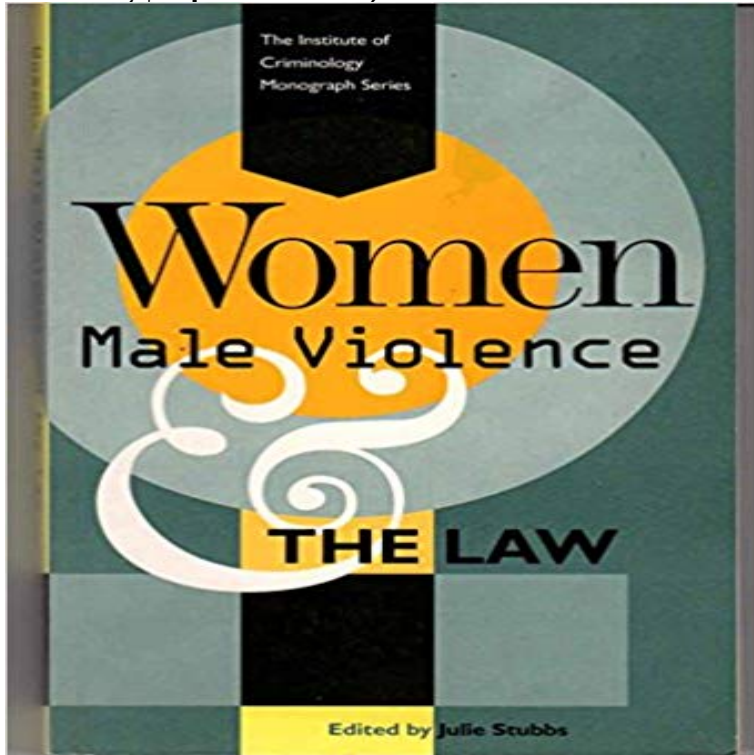


Women, Male Violence and the Law (Institute of Criminology Monograph Series)
