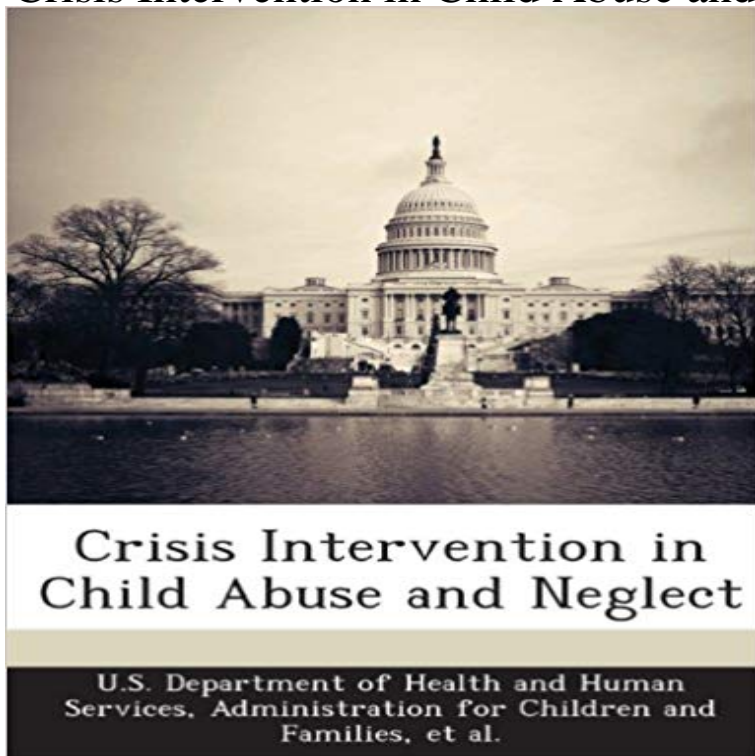


# Crisis Intervention in Child Abuse and Neglect
