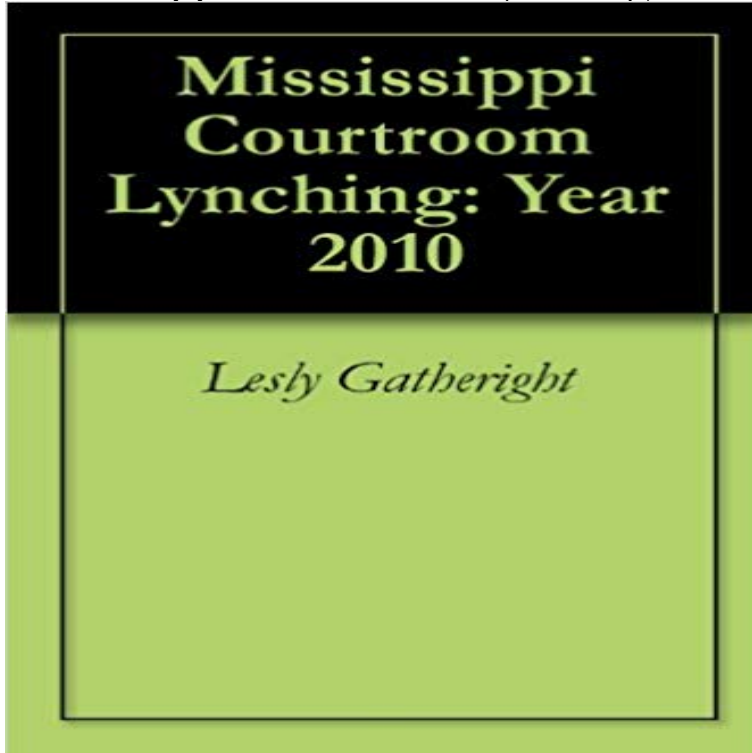


## Mississippi Courtroom Lynching: Year 2010
