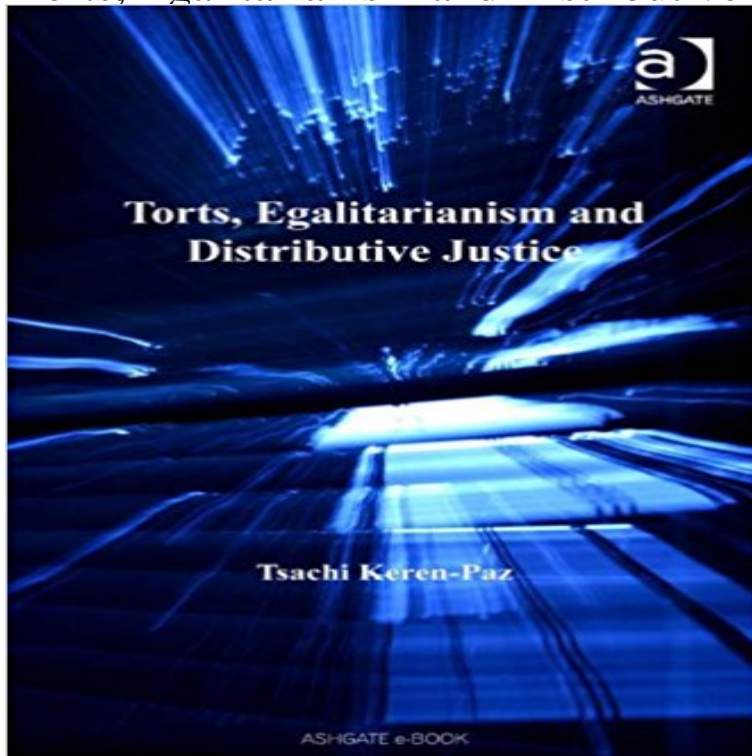


## Torts, Egalitarianism and Distributive Justice
