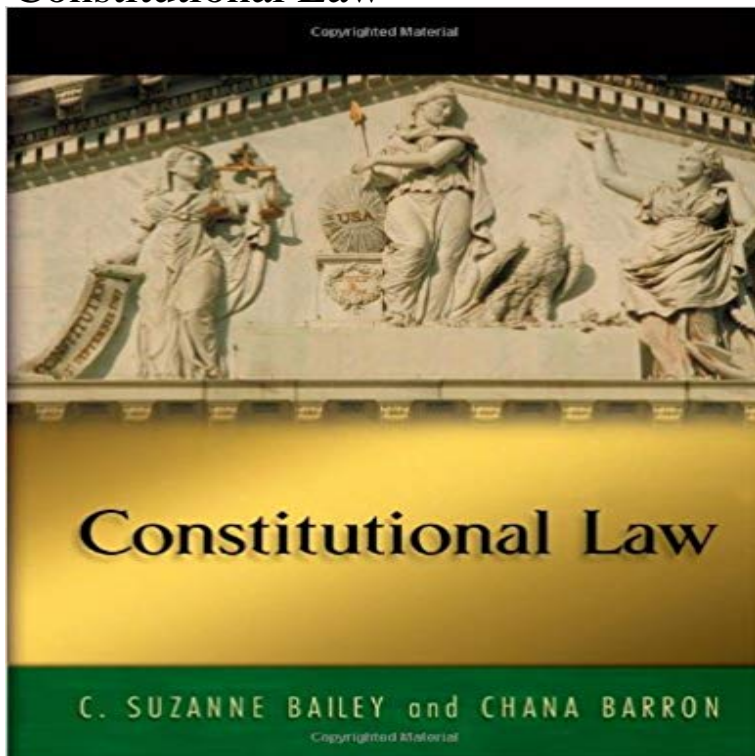


# Constitutional Law
