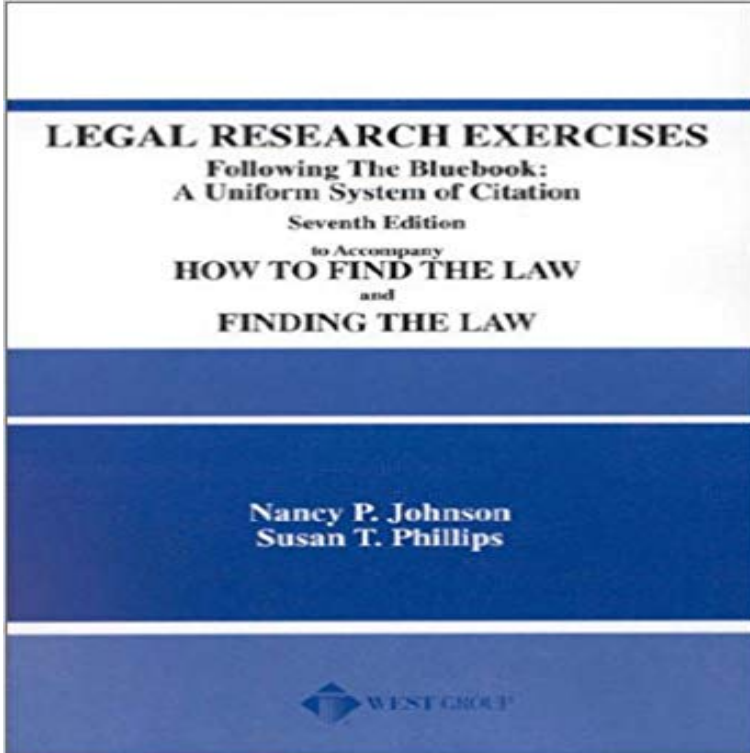


## Legal Research Exercises: Following the Bluebook, 7th Ed. (American Casebook Series and Other Coursebooks)
