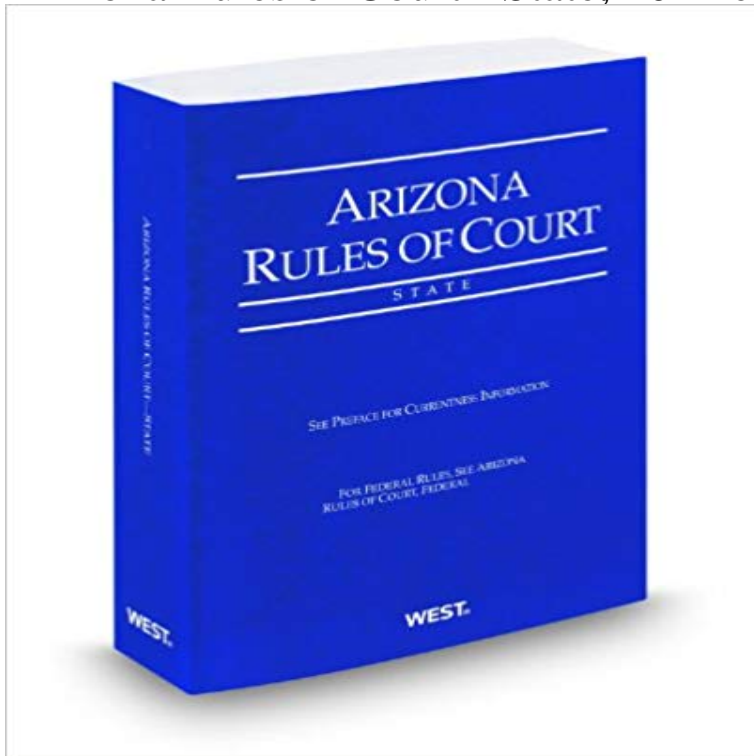


## Arizona Rules of Court - State, 2011 ed. (Vol. I, Arizona Court Rules)
