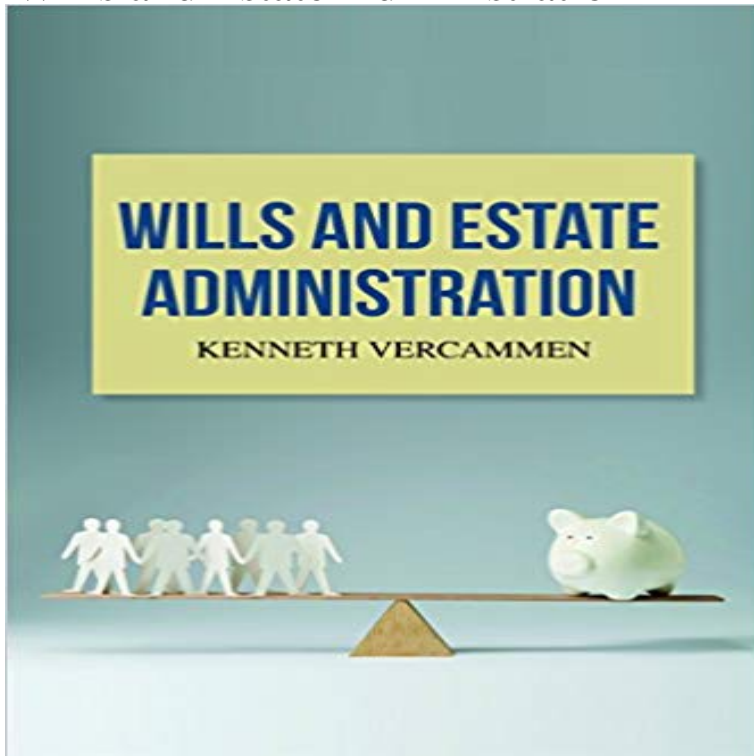


Wills and Estate Administration
