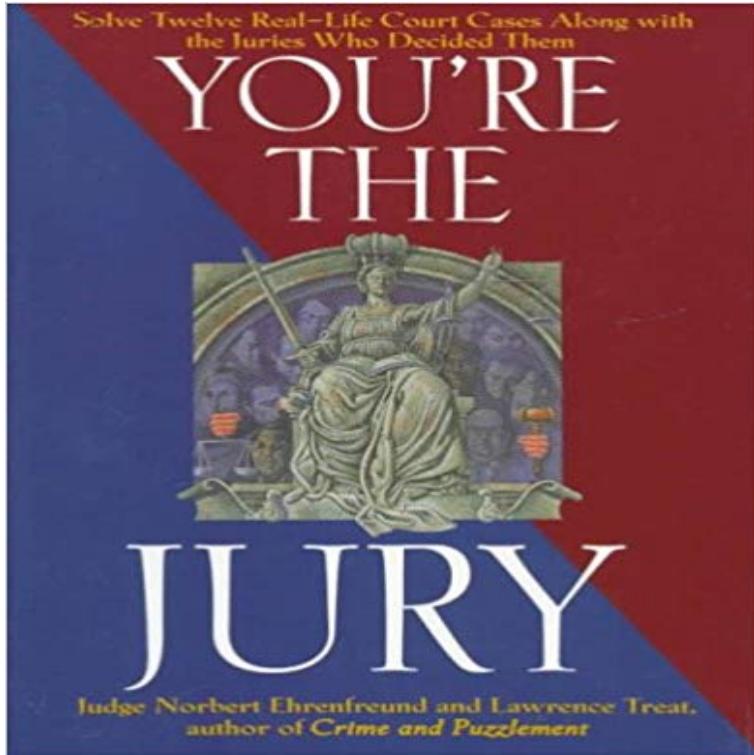


## You're the Jury: Solve Twelve Real-Life Court Cases Along With the Juries Who Decided Them
